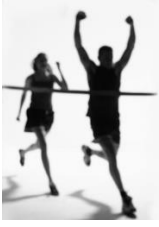


23rd Annual Memorial Fun Run/Walk



**23rd ANNUAL MEMORIAL DAY
CHRISTMAS LAKE FUN RUN/WALK
Memorial Day – May 31, 2021**



According to Governor Walz's new COVID-19 restrictions effective May 28 and CDC guidelines, all capacity limits for COVID-19 will end. Facemasks are only be required for the largest outdoor events, commercial events much larger than our Christmas Lake Annual Memorial Day Fun Run/Walk so we are not requiring facemasks for the event. Of course, if you wish to wear a facemask, please feel free to do so. We are planning to hold the Fun Run/Walk as in the pre-pandemic days.

Below are the rules for the Fun Run/Walk:

- The Fun Run/Walk will begin and end in the cul-de-sac at the end of Christmas Lake Road at 9:00 am.
- The walkers and the child bikers will start together 10 minutes before the adult runners.
- The entry fee is \$25.00 per person which contributes to the charity donation to be selected by the CLHA Board of Directors. Each entry fee comes with a T-shirt (shown below).
- You can pay your entry fee ahead of the race time by specifying the number of entry fees you are purchasing and T-shirts by size and sending a check to the Christmas Lake Homeowners Association, 890 Pleasant View Road, Chanhassen, MN 55317. The T-shirts come in sizes Extra-Small (XS – may work for older children), Small (S), Medium (M), Large (L) and Extra-Large (XL).
- Your pre-ordered T-shirts will be available at the registration table at the cul-de-sac at the end of Christmas Lake Road from 9:00 – 11:00 am. T-shirts not picked up in this time frame will be delivered to your home address.
- Day of registrations can be done at the same registration table.
- You can also purchase entry fees and T-shirts in the Cul-de-sac between 9:00 – 9:30 am.
- Bananas and water bottles will be available after the race.
